

Classic Country 1290 WIRL Drawing Contest with 4-H and Prairie Farms Official Rules

CONTEST: Beginning April 7 thru May 13, 2011, Classic Country 1290 WIRL will invite children ages 8-18 to draw a picture incorporating the 4-H logo and the Prairie Farms logo.

QUALIFICATION: All children between the ages of 8 and 18 will be encouraged to creatively incorporate the 4-H logo and the Prairie Farms logo into an original drawing. Their drawing will act as an entry into this contest and must include their name, the name of a parent or legal guardian, address and phone number. All entries should be hand delivered or mailed to the Classic Country 1290 WIRL Studios, 331 Fulton, Suite 1200, Peoria, IL 61602. All mail entries need to be postmarked by May 13, 2011.

PRIZE WINNER SELECTION: The Grand Prize Selection will take place the first week of June, 2011. Members of the Classic Country 1290 WIRL staff will determine the winner and his/her name will be announced on the "The Noon Show" with Meghan Grebner June 3, 2011. Members of the Classic Country 1290 WIRL staff will also determine which artists will receive runner up prizes and will contact them no later than June 7, 2011.

PRIZE(S): The grand prize winner will receive an iPod Nano (retail value \$150.00) and their design will be featured on the front of this year's Prairie Farms Dairy Hometown Fairs and Festivals t-shirts. The first runner up will receive an iPod Shuffle and a backpack (retail value \$75.00). The second runner-up will receive a backpack (retail value \$25.00). **All winners are responsible for reporting and paying taxes on prizes received.**

ODDS OF WINNING: The odds of winning will vary based on the number of contest participants.

RESTRICTIONS: **Participants must be between the years of 8 and 18 years to be eligible to qualify for or win this contest.** Contestants may enter as many times as they wish.

ELIGIBILITY: Employees and immediate family members and household members of JMP Radio Group LLC, Prairie Farms and employees of all other media outlets are not eligible to enter. (The term "immediate family" includes spouses, parents, siblings, grandparents, children, grandchildren, and cohabitating significant others.) Radio station reserves the right to disqualify any contestant who is financed, aided, encouraged or prompted by an employee or family member of any radio subsidiary within 100 miles of Peoria. Radio station reserves the right to disqualify any contestant if radio station deems the contest rules were not followed. Radio station contests are void when and where prohibited by law.

FUFILLMENT: All prizes awarded through radio station are non-transferable nor may a prize be substituted at the request of a contest winner, nor may a prize be substituted for cash. The prize indicated by station personnel to be won in a contest is the only prize awarded and given only to the person who is designated as the winner. If a prize winner forfeits a prize for any reason, the winner will be required to sign a release to that effect and will have no further claim to the prize.

Radio station and all sponsoring entities are not responsible for missed "cue to call" opportunities caused by this delay. Participants found tampering with or abusing any aspect of this contest, or whom radio station and all sponsoring entities believe to be causing malfunction, error, disruption or damage will be disqualified. All entrants agree to grant radio station unlimited use of their name, voice, picture, quotation or facsimile, without consideration, in conjunction with their participation in any given contest.
